The investment objective of the Emerging Markets Core Equity Portfolio is to achieve long-term capital appreciation.

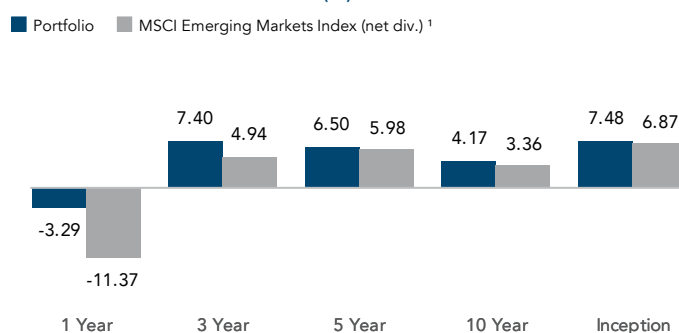
