The investment objective of the DFA Intermediate Government Fixed Income Portfolio is to earn current income consistent with preservation of capital.

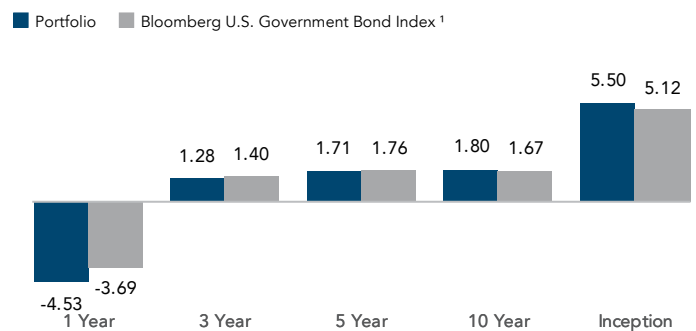

For example, if Moody's, Fitch, and S&P all provide ratings, we assign the median rating. In certain instances, such as Pre-Refunded Municipals and US Treasury and Agency securities, we will assign the internal Dimensional rating. The internal Dimensional rating can only be as high as the highest stated credit rating from an NSRSO.
